ACCOMPANYING NOTE OF THE REGISTRATION APPLICATION FORM

Pursuant to Article L. 5551-1 2° of the French Transportation Code "The seafarers that pursue any activity related to the operation of vessels under Article L.5511-1 (...) in accordance with the Maritime Labour Convention, adopted on 23 February 2006 in Geneva, who are employed on a vessel which flies the flag of a foreign State other than a vessel referred to in Article L.5561-1 and who reside in France on a continuous and legal basis, must be affiliated to the pension insurance scheme for seafarers, provided that they are not subject to the social security legislation of a foreign State under the EU regulations or an international social security agreement."

You must complete this registration application form in order to employ a professional seaman on board a vessel which flies the flag of a third State, outside the European Union, the European Economic Area, Switzerland or any State with which France has a bilateral social security agreement, in so far as that person is residing on a continuous and legal basis in France, in overseas departments or in the territories of Saint-Barthélemy, Saint Martin and Saint Pierre-et-Miquelon.

This form must be sent to the ENIM's contribution collection office (CCMA). Ensure that all fields are duly completed. After the application is processed, CCMA will confirm the affiliation to the special social security system for seamen.

You must report the services by submitting a monthly electronic report form no later than the 25th of the calendar month following the month when the services were performed. A quarterly collection document will then be issued that states all tax and contributions due.

Regulatory References

Classification: The seaman employed on a vessel that flies the flag of a foreign State and who is affiliated to the special social security system for seamen, has his salary classified under such flat-rate category, in line with the tasks performed and the vessel's characteristics, that would be his if the vessel flied the French flag. However, that category can under no circumstances be higher than the one the seaman could legally be entitled to in a French vessel, in view of his qualifications (Article 4 and 7 of decree 79-934, modified on 2 November 1979).

Shipowner: Definition in Article L. 5511-1 1° and 2° of the French Transportation Code.

Seaman: Definition in Article L. 5511-13° and 4° of the French Transportation Code

Continuous and legal residence: Means the place where a person habitually resides (permanent accommodation, tax residence, etc.)

Company's head office: Indicated in the Commercial Register (KBIS extract official document demonstrating the legal existence of a commercial enterprise).
